HOW TO REGISTER A COMPANY IN THE UK?

INFORMATION WE WILL NEED :

- 1. Company name and address*
- 2. Officer details*
- 3. Social capital and shareholders details*
- 4. Payment and registration*

FOCUS ON THE COMPANY NAME



** Name has to be unique*

→ We will check the availability of your name

** Add 'limited' or 'ltd' at the end*

** Avoid sensitive word and expressions*

→ Don't use: International, National, King, Group, name of Institutions and so on. Check the list before chose your name

** Name can't be similar to the existing one*

NB: The company name registration doesn't protect your trade mark!

FOCUS ON THE OFFICER DETAILS

DIRECTOR

INFORMATION YOU NEED TO PROVIDE :

- *Full name*
- *Usual residential address (not displayed on public record)*
- *Service address (can be the same as the registered office)*
- *Country/state of residence*
- *Nationality, occupation, date of birth and any former names (that have been used for business purposes in the last 20 years).*

NB: The director can be the non UK resident!

SECRETARY

NO MORE REQUIRED FOR A LTD

FOCUS ON THE CAPITAL AND SHAREHOLDER

NO MINIMAL CAPITAL REQUIRED,
ONE SHAREHOLDER IS ENOUGH

Memorandum of Association

- *The total amount of the social capital,*
- *The name and address of all initial shareholders (known as a subscriber),*
- *Company's registered address ,*
- *The nominal value and amount paid on each share, currency and totals*

Articles

- *Gouvernance details*
- *Rights and obligation of the Director*
- *Rights given by each type of share*
- *Restriction of shares transfers*
- *Prevention of the Director's revocation*
